August 2025-January 2026: UWGEC review should prioritize CLCK classes.

Feb 1, 2026: All courses that will carry a civics designation for Fall 2026 need to be in place/approved by UWGEC.

Feb 15, 2026: All modified courses that want to be available for priority registration approvals that need to be active for Fall 2026 must reach final approval by 2/15/26.

Aug 1, 2026: Last day for Fall 26 UA Course Add forms to complete approval route including 10-day campus review.

August 2026: Attributes become graduation requirements.
