By minimizing required courses and offering electives drawn from the several departments of the Eller College of Management and the Mel and Enid Zuckerman College of Public Health, the proposed curriculum offers greater flexibility to accommodate the unique needs of a variety of student career goals. This flexibility is appropriate given the diversity of majors offered by the Eller College (e.g., accounting, finance, economics, management, marketing, and management information systems). Because Eller undergraduate degree majors allow for relatively few electives, the requirement of only 12 units (with up to 6 units applied to the student's major) increases the likelihood that students can complete the certificate within the total number of units required for the degree.

The curricula of all four certificate programs provide similar foundational knowledge of the US health care system, introducing students to the health care industry and preparing them for entry-level positions. NEW CERTIFICATE PROPOSAL: Healthcare Business Management

I. CERTIFICATE DESCRIPTION-.

The joint Eller College of Management and Zuckerman College of Public Health undergraduate Healthcare Business Management certificate enhances the employability of undergraduate students interested in careers in healthcare. The program is designed with maximum flexibility to allow students to draw from healthcare-related courses in accounting, economics, entrepreneurship, management and organizations, management information systems, marketing, and public health to create a plan tailored to their own interests and career goals.

II. NEED FOR THE CERTIFICATE/JUSTIFICATION -

The Eller College has offered its undergraduate students an unofficial concentration in healthcare management for many years. The intent of this certificate is to collaborate with the Zuckerman College of Public Health to provide Zuckerman Public Health and Eller Business students with an official recognition of that concentration and enhance their understanding of health care policy and management. A University of Arizona undergraduate certificate in healthcare business management will provide students interested in careers in the healthcare industry with an important credential for launching or furthering their careers.

There is steady interest in healthcare content from Eller undergraduate students. Eller healthcare-related courses in accounting, economics, and management are regularly enrolled at, near, or over capacity. In addition, since 2011, 104 students have expressed interest in the unofficial concentration in healthcare management¹. Eleven students have completed the concentration, and an additional 3 are currently pursuing it. The official recognition conferred by a university certificate may attract more students to complete the healthcare business management curriculum.

Demand for bachelors-prepared healthcare administrators is strong and growing. Occupations in healthcare administration and management for bachelors-prepared applications is expected to grow by 17.5% between 2022 and 2032². Between January 2021 and July 2022, there were 2.21 million unique job postings in this category. Top employers in this category include insurance (e.g., Anthem Blue Cross, Humana, UnitedHealth Group), consulting (e.g., Deloitte, KPMG, PricewaterhouseCoopers), healthcare delivery (e.g., HCA Healthcare), and newer ventures (e.g., Amazon). Open positions indicate a variety of occupations highly suited to graduates of business majors, including human resources generalists and managers, recruiters, office managers, and project coordinators. Similarly, the specialized skills most frequently identified in relevant job postings are those which are developed in undergraduate business majors, including marketing, auditing, finance, process improvement, project management, talent acquisition, accounting, and performance management.

III. PROGRAM AFFILIATION-

The certificate will be affiliated with the Bachelor of Science in Business Administration (all majors) offered by the Eller College of Management.

The Mel and Enid Zuckerman College of Public Health will collaborate, offering courses to be included in the certificate program in addition to courses offered by the Eller College.
