Therefore, we have the faculty expertise, the facilities, and the equipment to support this minor. An important aspect of the strategic plan for the College of Fine Arts is the building of robust enrollments in its BA programs. This new minor will increase the enrollment in TFTV by 10-20 students each year.

Musical Theatre Minor (<u>Undergraduate</u>) CURRICULAR INFORMATION

I. MINOR DESCRIPTION:

Ignite your passion for the stage with University of Arizona's Musical Theatre minor. Musical Theatre is a genre that combines acting, singing, and dance skills to create a "triple threat" performer. The minor in Musical Theatre will develop and refine skills in acting, dance and voice. Students will take courses in performance classes in various styles including acting, basic musicianship, group voice, scene study, Musical Theatre dance styles, professional development, and Musical Theatre history. This minor can be combined with any major.

II. JUSTIFICATION/NEED FOR THE MINOR:

The School of Theatre, Film and Television (TFTV) has a long history of Musical Theatre as a program.

The major used to get 600 plus auditions annually. While TFTV could no longer support a whole Musical Theatre major, it can support a Musical Theatre minor. With our Live and Screened Performance major there is a lot of interest in Musical Theatre. That program intends to have 60 students per year, and TFTV believes at least half of those students will want to minor in Musical Theatre.

III. VIABILITY:

The School of Theatre, Film and Television will be redeploying resources. We already have the spaces in the Drama building to house these courses. We also already have the professors to teach these courses. TFTV sunset its musical theatre major, so all the coursework already exists and the faculty are remaining here to teach.

Like our Musical Theatre major, this minor has to remain small in order to adequately teach the students in the minor the skills needed for musical theatre performance.

There are other institutions that have a Musical Theatre minor. ASU, University of Nebraska, Kutztown University, and Fairleigh Dickenson University.

- ASU's program differs from our proposal because there are restrictions on which majors can minor in Musical Theatre due to programs not being compatible in nature. We are not looking to limit any major from this minor. ASU's program is also 24 units total and the courses there vary from ours. ASU requires a core set of courses that includes Theatre production, which are courses that are for the design of a show, not the actual acting, dancing, or singing in a show. ASU also requires music theory and musical theatre history. This minor proposal will not be requiring musical theory and musical theatre history. Lastly, ASU only allows for two dance courses in its minor, we have the option for four dance courses.
- The University of Nebraska's minor is simple only requiring 18 units and all the courses are required. Courses include topics in music theory, voice courses, keyboard, dance, putting on shows, and techniques. Their program has no flexibility music theory and keyboard, which our minor will not have.
- Kutztown University minor in musical theatre is very different from our minor proposal. It has only one elective and five required courses. All courses in the program are music- or acting-based. There are no dance course options in the program. It is an 18-unit minor.
- Fairleigh Dickenson University also differs from our program in that it is a much smaller minor only requiring 15 units total. Students take courses in vocal performance, theatre production, music theory/history, acting and dance. Our program proposal will not require production or music theory/history courses.

All three programs have courses that cover the basics of musical theatre. Coursework covers acting and vocal areas of Musical Theatre training.

2. How does the proposed program stand out or differ from peer programs? Briefly summarize the differences between the proposed program and peers, which could include curriculum, overall themes, faculty expertise, intended audience, etc.

The proposed program is different from the peer comparisons because no specific major is required or not allowed to be combined with the proposed minor. The proposed program also only has one required course versus multiple required courses, and it requires less overall units than the peer programs. In the USC program there are many more acting courses available. For ASU's program most courses are music based and there are no dance options available. USC only has one dance course available for students to take. Our program has multiple dance and voice course options. Students in our program will have the opportunity for performances. That doesn't seem to be an option in the USC program.

3. How do these differences make this program more applicable to the target student population and/or a better fit for the University of Arizona?

The University of Arizona's program gives a more well-rounded approach to training. Students will have courses in all 3 emphases (Acting, Voice and Dance) to obtain the minor. Peer institutions offer courses in 2 of the 3 emphases, but not courses to build skills in all 3 areas. Additionally, students can enroll in the MT Minor as Theatre LSP majors, Dance majors, Music majors or a totally unrelated field. This gives the students at the University of Arizona an opportunity to train and strengthen skills in the Musical Theatre art form while they are obtaining another major. Our proposed program also is more flexible in nature, and it allows our students to perform outside of the classroom.

Director's Statement

The two faculty members who will staff the classes in this minor are both already members of the TFTV faculty. Professor Christie Kerr is a tenured, Associate Professor and Professor Jamie Reed is a Career Track, Assistant Professor of Practice. Both these faculty members taught the core classes in the BFA in Music Theatre that has been discontinued. We are therefore utilizing their expertise to teach this minor and that is why we are not adding new instructors in this Minor. We also have the musical and space capacity from the discontinued BFA to utilize for this Minor and therefore we have no material costs associated with this new degree plan. Without this minor, Professor Kerr and Professor Reed would have no curricular outlet for their expertise and TFTV would have to invent classes to fill their teaching load.

We have not completed the **Metrics** portion of the form because it is unclear what the budget model will be for the University and whether student credit hours will be an income source in any new plan. We expect approximately 10 undergraduate students per year will take the Minor who are not already TFTV majors.
