SUBJECT: Other Academic Fee – Incoming Student Fee

The proposal to merge two ABOR-approved *Other Academic Fees* into a single, streamlined amount has been approved in collaboration with the Office of Undergraduate Education, Student Success and Retention Innovation, and Student Affairs Administration. The Arizona Board of Regents (ABOR) will be informed of this change during the tuition and fees setting process in Fall 2025. Since this consolidation of two existing ABOR-approved fees does not alter the overall amount, purpose, justification, or the population assessed, it does not necessitate their approval. Purpose:	The purpose and Justification of this fee remain the same as approved initially by ABOR in 2008 and 2019. This request pertains to combining two current 'other academic fees.' Specifically, it involves the Student Support Fee of \$100, which is charged to all incoming first-year students, \$50 to all incoming transfer students, and the First Year Fee of \$20, also charged to all incoming first-year students. The new combined fee will be named the "Incoming Student Fee." It will total \$120 for all incoming first-year students and remain at \$50 for all incoming transfer students, meaning there will be no change for transfer students. The overall amounts, purposes, justifications, and the populations required to pay these fees will remain unchanged. Also, the administrative units that handle this revenue and own this fee will remain the same: Office of the Provost -Undergraduate Education, Student Success & Retention Innovation, and Student Engagement & Career Development.

### **BACKGROUND:**

Following a surveying of the student body in fall of 2007 it was determined that The University of Arizona would proceed with a Student Services Fee to be implemented over the following two years. When polling students to determine their support for the fee it was not only clear that the entire student body would be supportive of a fee of this nature, but more specifically that the most supportive both of the fee in general and of the highest dollar amount per semester was the Freshman respondents. The vast majority of that population (92% of respondents) was supportive of the highest bracket option available on the survey of \$66 - \$85 per semester in the form of a student services fee. This response comes as no surprise considering the freshman class is the most in need and largest consumption group of student services on campus.

### **DISCUSSION:**

Considering the survey results relative to the freshman respondents, it seemed necessary to make a special portion of the student services fee to be focused directly on the freshman class. In order to meet the needs and wants of new students at The University of Arizona a one-time fee of \$20/year is proposed to be charged to all first year students. All money collected through this fee will be targeted towards first year student success programs and support services. Uses of this fee would include tutoring (freshmen are particularly vulnerable in math, writing and several specific general education classes), welcome activities which would include opportunities for students to get connected to campus (the first weekend of school is a time when we "lose" students), convocation and other programs focused at helping our freshmen feel a part of this community and have

the support to be successful academically. These students are the most vulnerable demographic to dropping out, the more services that are offered to them for their success the better. This additional \$20/year fee would be allocated through recommendations made to the Vice President for Student Affairs by a committee made up of students, staff and faculty that represent the interests of first year student retention. Fifteen percent of the fee revenues will be set aside for need-based student financial aid.

### **RECOMMENDATION:**

The University of Arizona recommends ABOR approval to implement a special fee of \$20 per year for all first year students to support first year student success programs and support services as recommended by committee of students, staff and faculty, and approved by the Vice President for Student Affairs.
