The current journalism minor requires students to take six courses that are only open to students enrolled in the minor. After several years of summer only classes and one year of online summer classes, we have learned that offering the minor only in the summer was a significant barrier for students who were interested in the minor. We have also learned the minor-specific classes made it difficult for students in the minor to declare a double major.

School research indicates that our current summer-only minor isn't as appealing as we had hoped. According to a survey taken by 57 non-majors, only 13 percent of respondents said they were very interested in a summer-only minor. In the same survey 67 percent of the respondents preferred to take their minor classes in Fall/Spring, and almost 78 percent of the students said they want flexibility in the classes they take to complete their minors.

In order to better serve students interested in journalism, we propose doing away with minor-only classes and instead requiring minor students to take four core classes currently offered in the major program. Minor students will also select two upper division journalism electives to complete their minor. It is likely that several of the required classes would also be offered in the summer, creating more flexibility for both major and minor students.

VI. **Peer institution comparison**- describe how your modified minor requirements are similar and different from minor requirements of two peer institutions. Select peers from (in order of priority) <u>ABOR approved institutions</u>, <u>AAU members</u>,

The first peer institution is the University of Texas at Austin School of Journalism. Like the UA School of Journalism, it is an ACEJMC-accredited program. UT Austin's minor also mixes minors and majors in the same classes. They require two core fundamental classes and then allow students to select three electives for a total of five classes.

The second peer institution is the Montana University School of Journalism. Like the UA School of Journalism, it is both an ACEJMC-accredited journalism program and is also one of the few journalism programs in the country that does not also teach public relations, advertising or communication. Similar to our proposal, students in the Montana minor take a suite of required classes that are for both major and minors. Our minor is three fewer units and offers two electives, while theirs offers only one elective.

VII. Faculty impact-indicate if new faculty hires will be required to deliver the proposed modified/new curriculum.

No new hires will be needed to deliver the modified curriculum. Three of the four required courses are lecture classes with available space and are offered in both Spring and Fall semesters.

The required reporting class has a cap of 20 students because of accrediting body rules. It is possible that if the minor grows, we may need to offer an additional section of JOUR 205, but we have the capacity on our faculty to teach the class. An additional section will be advantageous to majors because it will offer more flexibility in course times/sections.

We offer various electives on a rotation each year, and they generally have several open seats. Minor students will be able to take these six units of electives without the school's having to hire new faculty.

VIII. Budgetary Impact– indicate new resources needed and source of funding to implement the proposed changes. If reallocating resources, indicate where resources will be taken from and the impact this will have on students/faculty/program/unit.

It is possible that we may need to offer an additional section of JOUR 205, which can be taught by core faculty. However, if the extra section cannot be taught by a faculty member, we can hire an adjunct using temp teaching funds. If an extra section is added because of additional minor enrollment, it will be offset by an increase in our SCH. It's also possible that we may need an additional photo lab section. The lab is run by student workers at a rate of \$11 per hour paid from program fees, so the additional cost, if needed, would be \$264 per semester.

Because we are moving away from a summer-only minor, our summer revenue might be impacted. We use this money for operations. However, we hope that by allowing minors to take major classes, we can offer classes in summer that both majors and minors would be interested in and will actually increase summer enrollment and summer revenue.
