# NEW CERTIFICATE PROPOSAL

OF ARIZONA

Developed and implemented by public health experts with extensive experience of global health research and practice, and underpinned by the United Nations' Sustainable Development Goals as the guiding framework, the University of Arizona's **Undergraduate Certificate in Global Health** will equip participants with foundational knowledge and skills that are necessary to engage effectively in global health practice - whether at home in a diverse setting, along the border in a bi-cultural environment, working side-by-side in indigenous homelands or abroad where populations and communities are displaced and under-resourced, and where health systems are severely constrained. Participants will be introduced to the world's vast diversity of determinants of health and disease. They will have an opportunity to critically appraise health systems in different parts of the world, and analyze current and emerging global health priorities, including infectious diseases, poverty, conflicts and emergencies, health inequity, principles and impact of health systems reforms, and major global initiatives for disease prevention and health promotion. Delivered entirely online, participants can complete the certificate in one academic year and will have the ability to transfer the associated 12 units to future undergraduate programs in public health at the university of Arizona.

Global health is defined as 'an area for study, research, and practice that places a priority on improving health and achieving equity in health for all people worldwide. It emphasizes transnational health issues, determinants, and solutions; involves many disciplines within and beyond the health sciences and promotes interdisciplinary collaboration; and is a synthesis of population-based prevention with individual-level clinical care. In 1997, an Institute of Medicine (IOM) report, "America's Vital Interest in Global Health: Protecting Our People, Enhancing Our Economy, and Advancing Our International Interests" brought to the American public and policy makers, an appreciation for America's direct stake in the health of people around the globe. It defined global health as "health problems, issues, and concerns that transcend national boundaries, and which may be influenced by circumstances or experiences in other countries and are best addressed by cooperative actions and solutions.2" These definitions reflect a closely linked world, where the globalization of commerce, communications, and travel bring an immediacy that magnifies our opportunities and our problems. For human health, connectedness of knowledge and technology can obviously support surveillance, treatment, and prevention. However, rapid movement of people - some of whom are ill with an infectious disease, movement of food that can be contaminated, water and air that can be polluted, toxic substances and even terrorism across national borders, bring increased health risks. Given the importance of global health for equity and social justice around the world, individuals and organizations have a passion to address these global challenges, and a sense of urgency to promote social justice. Indeed, as Koplan et al.1 observe, global health provokes a great deal of media, student, and faculty interest, has driven the establishment or restructuring of several academic programs, is supported by governments as a crucial component of foreign policy, and has become a major philanthropic target. To train the public health workforce to meet the growing demand, there has been rapid acceleration in the creation of global health programs, and a doubling of undergraduate and graduate enrollments in global health programs in US universities.

The Mel and Enid Zuckerman College of Public Health (MEZCOPH) is dedicated to promoting health and wellness of individuals and communities in the southwest and globally with an emphasis on achieving health equity through excellence in research, teaching and service. currently offers an emphasis area in and minor in global health in the BS in public health program on main campus and online. The College also offers a Graduate Certificate and a Master of Public Health (MPH) degree in global Health. We propose an Undergraduate Certificate in Global Health as an extension of our mission of promoting health and social justice locally and globally. The proposed undergraduate certificate in global health aligns with UArizona's strategic Pillar #4 (Arizona Global) and is not duplicative of existing programs.

The current COVID-19 pandemic has brought a sense of immediacy to the saying that "public health is everywhere." It has become very clear that SARS, Avian flu, Ebola, West Nile virus, TB, Malaria, Hepatitis, and HIV/AIDS are not distant health challenges that do not concern us. Given the increased awareness of the need for shared solutions to these shared problems of humanity, opportunities in global health work abound, and more individuals are expressing interest in careers in global health. Given the paucity of global health trainings at the undergraduate level nationally and indeed globally, the proposed undergraduate certificate provides an opportunity for early entry to global health training and career for University of Arizona students. Careers in global health present the opportunity to work with people from different backgrounds and to help those in need around the world. Global health professionals may work with national leaders to shape health systems in resource-limited settings. Others may collaborate with government agencies and non-governmental organizations or relief agencies to address social determinants of health and promote population health. An undergraduate certificate in global health will be attractive to students from across the University of Arizona campus, UArizona Online, and UArizona Global Campus Direct. Given the online nature of the program, students from across the UA and other universities in the US and overseas will be able to take it and will be able to transfer the associated units to public health degree programs at UArizona. Job prospect for those graduating with either a BS or Graduate degree in related Public Health disciplines are very good. Expected career growth in public health is between 5-18 % with salaries ranging from \$46,000 -\$76,000<sup>1,2,3</sup> According to a recent Burning Glass market analysis, over 61,000 public health jobs were listed nationally between November and December 2020. The average salary in the nation for graduates of a global health program is \$60,935. Market data continues to show that careers in global health are expected to grow significantly in the next 10 years.

1. How does the proposed program align with peer programs? Briefly summarize the similarities between the proposed program and peers, which could include curriculum, overall themes, faculty expertise, intended audience, etc.

The proposed undergraduate certificate in Global Health is similar to its peer programs in several ways. The overall theme of improving public health within a global context is present in all three programs, including the study of disease and illness prevention as well as the socio-economic and environmental conditions that lead to health inequities around the world. All three programs are condensed, focused study in the field of global health which can be completed by undergraduate students within one year.

2. How does the proposed program stand out or differ from peer programs? Briefly summarize the differences between the proposed program and peers, which could include curriculum, overall themes, faculty expertise, intended audience, etc.

The UA College of Public Health has a unique opportunity, post COVID-19 pandemic, to develop an undergraduate certificate in global health with a targeted focus on infectious disease outbreaks and public health emergency preparedness. The peer programs at University of Wisconsin, Madison and Ohio State University are much broader in scope, with a more generalized public health curriculum. In addition, the proposed certificate in Global Health requires 12 units and will be available fully online, as compared to 15 units, in-person, at our peer institutions.

3. How do these differences make this program more applicable to the target student population and/or a better fit for the University of Arizona?

The proposed undergraduate certificate in Global Health draws upon the strengths of MEZCOPH faculty's expertise in disease outbreaks, management of public health emergencies, public health preparedness and the planning and evaluation of global public health programs. Unlike our peer institutions, this program allows non-degree seeking students with a high-school diploma the opportunity for quality professional development in global health. Students who choose, may continue to pursue a bachelor's degree in public health at the University of Arizona and apply six units toward either a BA in Wellness and Health Promotion Practice or BS in Public Health. The certificate is offered fully online which will provide students the opportunity to advance their educational and career goals regardless of location or family/work commitments that may prevent them from pursuing in-person instruction.
